Portrait of NC Home Health

- In the fall of 2018, the North Carolina Division of Health Service Regulation reported 208 Medicare certified home health agencies in North Carolina (corporate and branch offices).
- Data from the "Home Health Agency 2018 Annual Data Supplements" indicated a total of 227,778 home health patients were served during 2017 (FY 2016-2017).

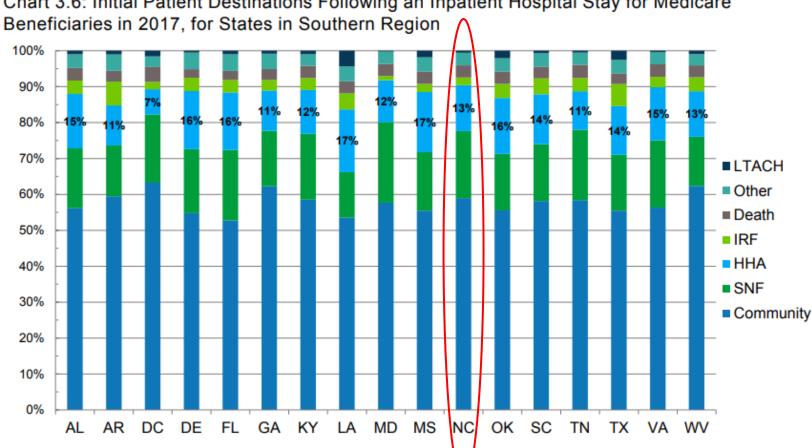


Chart 3.6: Initial Patient Destinations Following an Inpatient Hospital Stay for Medicare

- Right at Home and ComforCare announced in 2018 the formation of a preferred partnership agreement with Kindred at Home (owned by Humana, Inc.)
- Medicare Advantage
 - CMS' approval of MA/Home Care Support
- Launching specialized care programs
 - Heart failure, COPD, dementia and other complex conditions
