### **Task Force Meeting 7 Recap:**

At our previous meeting, we explored behavioral health aspects of the prenatal and postpartum period. Particularly, task force members were given overviews of existing services and barriers for expectant mothers struggling with substance abuse, and opportunities to receive coordinated prenatal and behavioral healthcare. Coordinated care was further explored in the context of developing mental health postpartum care services for mothers, and the task force heard from a community member about her experience and struggles with the limited services in the state. Finally, the task force heard a presentation on the role and impact of genetic counseling, and its role in perinatal care.

### **Looking Forward – Task Force Meeting 9 (7/29/2019):**

At our July 29<sup>th</sup> meeting, we hope to focus on the postpartum period. We will discuss the role and value of community support programs for mothers, babies, and extended families. Specifically, we will explore home visitation programs, support groups, and lactation services. During our discussion of these topics, we hope to incorporate identification and continued awareness of the impact of social disparities and racial bias on maternal and infant outcomes in the postpartum period and beyond.
