To start off, Ms. Hamlin talked about the history of HLLA, the work that they do, and provided some background information on hearing loss, the ADA, and section 504 rules related to communication access. She also provided an overview of different policy solutions to improve communication access for the hard of hearing.

### **Discussion: Draft Recommendations**

After Ms. Hamlin's presentation, Robert Kurzydlowski facilitated a large group discussion focused on developing recommendations based upon presentations and dialogs around long-term care during the 4<sup>th</sup> Task Force meeting. Topics discussed included hearing screenings, the role of audiologists in long term care, regulation of long-term care facilities, universal design, and the education of providers on the linkage/similar presentation of symptoms between hearing loss and chronic diseases. After discussion, the Task Force took a break for lunch.

#### **Promoting Hearing Health in Older Adults**

Following lunch, the last presentation of the day was from Dr. Nicholas Reed an Assistant Professor at John Hopkins University. Dr. Reed talked to the Task Force about his research around hearing-related hearing loss, the consequences of hearing loss in older adults, and how age-related hearing loss can be addressed. He also gave some examples of hospital-based hearing programs at John Hopkins designed to identify hearing loss among patients and community-based intervention.
