#### **Cumberland County Data-Placement Stability of Children in DSS Custody**

### Focus of data Request - Quarters (10/15-12/15), (1/16-3/16), (4/16-6/16), (7/16-9/16)

- # of Children in DSS Custody in Cumberland County
- Type of placements
- # of moves
- Reason for moves

Cumberland County Department of Social Services has an ACCESS-based System that collects placement information for children in DSS custody. Social Workers input information into an electronic PLACEMENT/REMOVAL Form for each child: when the child enters DSS custody, when the child moves from a placement and when the child leaves DSS Custody.

#### The CCDSS Placement Removal Form collects:

- The Child's Name, SIS ID, Date of Birth,
- Initial Placement in Foster Care-Type, Beginning Date
- Home removed from (Names of Parents/Caretakers, Type, Address, date removed)
- Living arrangements that the child has been placed in by Type, Facility ID and Beginning & End dates.

#### **Barriers/Gaps with Internal Data:**

- The DSS-5094 and the CCDSS Placement/Removal Form do not collect the REASON FOR A PLACEMENT MOVE
  - Reasons for the child's placement move cannot be queried using CCDSS electronic data sources
    and due to the volume of data, it is not reasonable to expect accurate data collection by
    reading the case files of all 900 plus children in CCDSS custody.
  - Data regarding the Reason for a Placement Move must be collected by reading a combination
    of "hard copy" and electronic case documentation or by surveying all social workers, who have
    children in CCDSS custody about the placement, moves and reasons for moves for the children
    in their caseloads.
  - All children in Cumberland County DSS custody do not have their entire placement history loaded into the ACCESS-based system; therefore, longitudinal data and point in time data is not available unless collected by reviewing individual case files.
  - To provide accurate longitudinal data regarding placement moves for on children in care: all children in Cumberland County Custody would have to be tracked form the same date of entry
