Last month, the task force heard from representatives of the Perinatal Systems of Care in Tennessee and Texas. The presentations were followed by small group discussions on the systems in place in Arizona, California, Washington and New York. Nancy Henley presented on Medicaid Transformation and engaged the group in a thorough question and answer session. The group then learned about the LoMC and NICU verification programs.
