## **Task Force Meeting 6 Recap:**

At our previous meeting, we engaged in discussions about prenatal care and the working draft of policy recommendations, specifically around the role and inclusion of birth center guidelines. Task Force members were provided an overview of prenatal care access and utilization in North Carolina, followed by a short description of PRAMS survey methodology and current data. Finally, the day ended on a presentation of the role and impact of Certified Nurse Midwives in prenatal care and a thorough overview of the Special Infant Care Program and Transitions Medical Home at Duke Children's Hospital.

### **Looking Forward – Task Force Meeting 8 (6/24/2019):**

At our June 24<sup>th</sup> meeting, we hope to focus on improving maternal and birth outcomes. Particularly, we will discuss the impact of centering and patient education on pregnancy and explore the roles of nonclinical prenatal and postpartum care providers such as doulas and community health workers. Finally, we hope to have a panel of representatives from the newly contracted PHP providers and a few local health departments across the state to discuss the effect of Medicaid transformation on pregnancy care in North Carolina.
