

# 2021 LEGISLATIVE HEALTH POLICY FELLOWS PROGRAM



The allocation of state funds is the most important responsibility of state legislators. Given the large portion of the state budget dedicated to health care and health-related services, the decisions legislators make regarding health policy have tremendous impact on North Carolina's economy and the health of individuals and communities across the state. The Legislative Health Policy Fellows Program will provide General Assembly members with the data and resources needed to make effective and evidence-based decisions about the health of our state. Over three full-day sessions during the fall of 2021, fellows will learn about health issues facing North Carolina, the state's priorities for health care delivery, and challenges and opportunities for improving the health of all North Carolinians. Participants will also have opportunities to network with health policy researchers, state agency staff, and legislative colleagues.
