### 9:15 – 9:55 Keynote: *Protecting Children's Mental Health & Restoring Our Future* Sandy Chung, MD, FAAP, 2023 President of the American Academy of Pediatrics (AAP)

In this session, Dr. Chung will discuss the importance of children's mental health to their overall well-being, and highlight key innovations in the provision of children's mental health care.



Pediatrician Dr. Sandy Chung has held over 30 state and national leadership positions, including AAP Virginia Chapter President and Founder and Medical Director of the Virginia Mental Health Access Program. She is the CEO of Trusted Doctors, a pediatric practice of over 180 clinicians in Virginia, DC, and Maryland and serves as Medical Director of Informatics at Children's National Hospital's Pediatric Health Network. Her passionate advocacy for child health and pediatricians has delivered major advancements in healthcare equity, mental health, EHR burden reduction, appropriate payment, physician well-being, and optimal child health policies.

She is the recipient of multiple awards including the March of Dimes Lifetime Heroine Award recognizing a lifetime of community volunteerism, the Clarence A. Holland Award for providing outstanding contributions to the community and demonstrating leadership in the field of political advocacy, and the Virginia Chapter Child Advocate Award for standing up for the rights, values, and recognition of Virginia's children.

As an avid educator of the next generation of pediatricians, her publications include articles on telemedicine, virtual learning, and health information technology. Dr. Chung received her medical degree from the University of Virginia and completed her pediatric residency at the Inova L.J. Murphy Children's Hospital. # Access to Preventive and Supportive Resources for Chronic Mental Illness in Children and Adolescents

In this session, panelists will discuss resources to prevent and treat chronic mental illness, including opportunities in integrated care and supportive resources for underserved communities. Panelists will also discuss what is necessary for effective treatment, including access to prescription medications, culturally competent care, and community-based strategies.

#### Caring for NC Youth at Risk of Suicide

In this session, panelists will discuss drivers of suicide risk among North Carolina's youth and community-level strategies to provide support for children most at risk. Panelists will also discuss key challenges to providing effective care for youth at risk of suicide, including accurate data collection, stigma, and needed resources for prevention, as well as potential policy solutions to reduce youth suicide.

#### Moderator: Kella Hatcher, JD, Executive Director of the Child Fatality Task Force

Kella Hatcher, JD, is currently the Executive Director of the North Carolina Child Fatality Task Force, a study commission that makes policy recommendations on child health and safety to the governor and legislature. Kella's background is in juvenile law and her previous roles include authoring juvenile law manuals for the UNC School of Government, serving as associate counsel for North Carolina's Guardian ad Litem Program, and working as an assistant district attorney. Kella currently serves on multiple state-level advisory groups and she has served in various volunteer leadership roles for organizations serving the needs of children. She received her law degree from UNC Chapel Hill and her undergraduate degree from Purdue University.

### Alberto Valido, BS, Research Assistant, Applied Developmental Sciences and Special Education, UNC

Alberto Valido obtained a B.S. degree in Psychology from the University of Florida and is currently a Ph.D. student in Applied Developmental Science at the School of Education at the University of North Carolina

Alberto's research is focused on the mental health and well-being of LGBTQ youth of color and protective factors that can buffer against the adverse effects of discrimination and bias-based victimization. His research examines the role of societal-level factors such as systemic inequality, racism, heterosexism, and cissexism and ways to combine individual, state- and policy-level data using integrative data analysis. Alberto also leads the evaluation of the suicide prevention program Sources of Strength in 11 high schools and is an active collaborator with the UNC Suicide Prevention Institute.

#### Jane Ann Miller, MPH, Comprehensive Suicide Prevention (CSP) Program Manager, NCDHHS

Jane Ann Miller has a Master of Public Health degree in community mental health administration, a BS in psychology, and fourteen years of experience in community mental health programs in Pennsylvania and North Carolina. She joined the state's Division of Public Health's Injury and Violence Prevention Branch in 2000 and currently serves as the Comprehensive Suicide Prevention Program Manager for the state's CDC grant.

#### John Paul Jameson, PhD, Professor, Department of Psychology, Appalachian State University

Dr. JP Jameson is a Professor of Psychology at Appalachian State University and a Licensed Clinical Psychologist in North Carolina. He received his Ph.D. from the University of Pennsylvania in 2009, completed a predoctoral internship at the Salem VA Medical Center, and completed a post-doctoral residency at the Baylor College of Medicine and Michael DeBakey VA Medical Center in Houston, Texas. His research and clinical interests focus on the prediction and prevention of suicide through means safety interventions. Dr. Jameson is a master trainer in Counseling on Access to Lethal Means (CALM), a suicide prevention protocol aimed at reducing access to the most lethal suicide methods for at-risk individuals. More recently, he joined CALM America as the chief operating officer. Additionally, he is involved in numerous community-based research projects, both locally and regionally. He also directs the Assessment, Support, and Counseling (ASC) Center, a school-based mental health program operating in area school systems that provide mental health services for K-12 students free of charge.

#### Michael Welker, MPA, ncIMPACT Initiative Community Engagement Director

Michael Welker serves as the community engagement director for the ncIMPACT Initiative at the UNC School of Government. In this role, he manages partnerships with civic leaders, policymakers, and researchers at UNC-Chapel Hill and across the state. #### School-Based Mental Health Supports

In this session, panelists will discuss the current state of mental health services within school settings. The discussion will include the role of schools and school systems in



providing mental health services, challenges and opportunities in developing a strong school-based mental health workforce, and data development to inform this work.

Ellen Essick is Section Chief of Specialized Instructional Support and Healthy Schools at the North Carolina Department of Public Instruction. She has more than twenty years of experience working with school districts and communities on health and wellness initiatives, including those that focus on health outcomes of vulnerable and marginalized groups. She holds a PhD in Educational Leadership and Cultural Foundations and more than ten years of progressive leadership at the state and national levels providing strategic guidance and cross-sector collaboration to align strategies and integrate metrics for health and education outcomes. Ellen is a long-term member of the Society and served on numerous committees over the years.

#### Natasha Scott, EdD, MSW, Executive Director, Student Services, Cumberland County Schools

Patrick Greene grew up in eastern North Carolina and attended East Carolina University as a North Carolina Teaching Fellow and later as a North Carolina Principal Fellow. As a principal he led Greene County Early College to become a National Blue Ribbon school. Since 2013, he has been the principal of Greene Central High School. In his time at Greene Central, he completed his Educational Specialist degree and Doctor of Education degree, both at East Carolina University with a dissertation focus on finding pathways to higher education for undocumented Latinx students. Dr. Greene led the school out of a low-performing status and into recognition as North Carolina's first comprehensive high school to earn a Model STEM School designation. He was named as Greene County's Principal of the Year in 2014 and again in 2022. In 2022, he was awarded the Wells Fargo North Carolina Principal of the Year. Dr. Greene continues to serve as the principal at Greene Central High School and works toward equity and opportunity for students and rural schools.

# Early Childhood System of Care Workshop – Discussions to foster collaboration and policy opportunities

In this workshop-style session, participants will have the opportunity to discuss the current context of home visiting, early childhood mental health care, and child care in North Carolina. Participants will share what they view as key challenges to strong systems to improve children's mental health, as well as opportunities for policy change and community-level strategies.

## Home visiting – facilitated by Melea Rose-Waters, MSW Senior Policy Director, Family Connects International

Melea Rose Waters, MSW, is the Senior Policy Director at Family Connects International. In her role at FCI, she aims to increase investments in the Family Connects universal newborn nurse home visiting model by influencing policymakers, actively collaborating with stakeholders, and building the capacity of national partners to advocate for resources on the local, state, and federal levels of government. She has over a decade of experience advocating for children and families on the local, state, and federal levels of government, in addition to nearly ten years of working directly with families who were involved with child welfare.

### Early Childhood Systems – facilitated by Charisse Hart, MBA, CEO of Ready for School, Ready for Life

Mrs. Morgan Forrester Ray is the Director of the EarlyWell Coalition at NC Child. Under her leadership, the initiative aims to improve mental health of children birth through eight by ensuring that infants and young children with mental health challenges can get the services they need. Mrs. Ray is a systems thinker, rooted in creating equitable systems for all. She is a multi-skilled program administrator with experience in government, for-profit, and non-profit sectors. Mrs. Ray received her undergraduate degree in Social Work, and her master's degree in social work with a concentration in Community, Management, and Policy Practice from the University of North Carolina at Chapel Hill.

Charrise Hart is the Chief Executive Officer at Ready for School, Ready for Life (Ready Ready)—a transformative initiative dedicated to breaking the cycle of intergenerational poverty in Guilford County, North Carolina. Ready Ready focuses on fostering the healthy development of vulnerable children,



equipping them with the tools they need to succeed in both school and life. With approximately half of the county's 55,000 children growing up in or near poverty, Ready Ready addresses the pressing need for upward mobility opportunities. Charrise has earned recognition for her contributions, including the UNC School of Social Work Distinguished Alumni Award. In 2022, she was honored with the C-Suite Award with the Triad Business Journal. Charrise is also active in public education and global service, holding positions on the Teach for America of Charlotte-Piedmont Triad Board of Advisors and the World YWCA Service Council. Charrise is an alumna of NC State University, holding a Bachelor's Degree in Sociology. She furthered her education with a Masters of Social Work from the University of North Carolina at Chapel Hill as well as an MBA from Wake Forest University.

# *Supports for Families and Healthy Environments* Workshop – Discussions to foster collaboration and policy opportunities

In this workshop-style session, participants will have the opportunity to discuss the ways in which concrete economic supports and healthy physical environments can influence children and families' opportunities for mental health and well-being. Participants will discuss the relationship between physical activity and overall well-being, as well as the ways that inequities in economic stability and access to healthy physical environments impact mental health.

**Economic supports** – facilitated by **Mat Despard, PhD, MSW**, Associate Professor, University of North Carolina at Greensboro and **Sharon Hirsch, BA**, President and CEO of Prevent Child Abuse North Carolina

Mat is an Associate Professor in the Department of Social Work at UNC Greensboro, Faculty Director with the Social Policy Institute at Washington University in St. Louis, and an Adjunct Assistant Professor at the Kenan-Flagler Business School at UNC-Chapel Hill. Mat conducts research on household financial security related to employment, public policy, behavioral interventions, and financial inclusion and technology. Prior to his academic career, Mat worked for several years in and with nonprofit organizations focused on access to health care, early care and education, and financial empowerment. He received his MSW and PhD from UNC-Chapel Hill.

Sharon Hirsch serves as the President and CEO of Prevent Child Abuse North Carolina, where she leads a team that focuses on making prevention a priority for NC and building capacity for communities to have the knowledge, support, and resources to prevent child abuse and neglect. She has more than 30 years' experience in nonprofit and government agency management, public relations, advocacy and child well-being. At PCANC she has led efforts to catalyze community prevention plans, has increased staff capacity to provide supports for evidence-based parenting programs and has secured more than \$1 million in new investments in prevention programming.

#### Healthy Environments facilitated by Aaron Hipp, PhD, Professor, North Carolina State University

J. Aaron Hipp, PhD, is a University Faculty Fellow; Professor of Community Health and Sustainability in the Department of Parks, Recreation, and Tourism Management; and Associate Director of Social and Behavioral Science Applications in the Center for Geospatial Analytics at NC State. His research focuses on equitable access and spaces to play with specific attention on measurement development. Dr. Hipp currently instructs courses on nature and wellness and evidence-based decision-making. He serves on the



Steering Committee for the National Physical Activity Plan and is an Interdisciplinary Research Leader with the Robert Wood Johnson Foundation.

#### Addressing the Mental Health Workforce and Facilities Capacity Crisis

In this session, panelists will discuss the mental health workforce, including challenges to education, retention, and distribution of mental health care professionals, as well as data development to understand the scope of need for services. Panelists will also identify areas of opportunity for building a strong mental health workforce.

Moderator: Therese Garrett, MD, Behavioral Health Medical Director, WellCare Health Plans

Dr. Therese Garrett is the Behavioral Medical Director at WellCare Health Plans. She has worked in both outpatient and crisis settings in community mental health, through the San Francisco Department of Public Health, as the medical director for the Foster Care Mental Health program and San Francisco Child Crisis. She also served as an outpatient psychiatrist in college mental health at North Carolina State University. Throughout her professional career she has been involved in supervision and training of psychiatry residents and fellows, both as volunteer faculty at UCSF and adjunct clinical faculty at UNC. Dr. Garrett received her bachelor's in psychobiology and bachelor's in philosophy from the University of Southern California in 1999. She then obtained her MD from the University of California- San Francisco in 2004. She completed her general psychiatry residency at the Harvard Longwood program, and fellowship training in child/adolescent psychiatry at UCSF.

#### Carrie Brown, MD, MPH, DFAPA, Chief Psychiatrist/Deputy Chief Medical Officer at NCDHHS

Carrie Brown, MD, MPH, DFAPA is NCDHHS Chief Psychiatrist/Deputy CMO, provides leadership for the behavioral health and resilience strategic priority, and serves as CMO for the state-operated behavioral healthcare facilities. She's a graduate of Princeton University, Duke University School of Medicine, and UNC Gillings School of Global Public Health (MPH) with Psychiatry training at Duke University Hospital. She's experienced in treating SMI within the community, inpatient, integrated care, and correctional settings; health services research; and as a research fellow with the Cecil G. Sheps Center for Health Services Research. She's an Associate Professor of Psychiatry at UNC School of Medicine and an Assistant Consulting Professor in the Duke SOM Department of Psychiatry and Behavioral Sciences.

## **Tauchiana Williams, DSW, LCSW**, Clinical Associate Professor and Director of Standing MSW Program, UNC Chapel Hill

Dr. Williams is a clinical associate professor, program manager and lead interventionist for the Substance Use Prevention and Education Research (SUPER) program at UNC-CH, School of Social Work. She directs the 12-month Advanced Standing MSW Program and coordinates the school social work license program. She was appointed by Governor Roy Cooper to serve on the North Carolina Social Work Certification and Licensure Board. She has received the Dean's Recognition of Teaching Excellence Award over several years. As a licensed clinical social worker, Dr. Williams has treated children and families through intensive in-home services and outpatient therapy offices for 18 years. She specializes in treating children who have experienced trauma and supporting youth with navigating anxiety and depression. She's served as a school social worker and currently operates a telehealth private practice. Dr. Williams received her



Bachelor of Arts from Wellesley College, Master of Social Work from UNC Chapel Hill, and Doctorate of Social Work from the University of Pennsylvania. She has been a member of the UNC Chapel Hill School of Social Work faculty since 2010.

#### Ann Rodriguez, MHA, Executive Director, i2i Center for Integrative Health

Ann Rodriguez is the i2i Center for Integrative Health Executive Director. Ann values the partnerships and collaborations with all stakeholders of the MH/IDD/SUD system and works to include all stakeholders in policy making.
